

# A Vision for Water: Planning for Abundance and Scarcity in Illinois

A panel of water leaders gathered at Harold Washington College in Chicago and discussed the economic, social, and workforce challenges of the region's water sector, bringing current policy positions to shape the next decade. This framing provided the audience with key statistics and priorities that must be considered in all future planning. Attendees participated in visioning workshops to identify gaps, synergies, and priorities for future MPC work.



# Untangling Zoning Impacts and Promoting Equity Through Reform

This event also took place at Harold Washington College and featured an esteemed panel of thought leaders who presented new research frameworks for analyzing land use and zoning. Following the panel discussion, working sessions with previously-engaged stakeholders explored initial research findings from MPC's Zoning and Land Use Assessment project and began a dialogue on potential future Chicago-based solutions.



# Imagine Sustainable Transit: A Private Reception and 'L' Tour


This day of programming began with breakfast hosted at McDonald's Corporate Headquarters featuring comments from transit advocates State Senator Ram Villivalam and State Representative Eva-Dina Delgado. Both legislators shared their vision for the region's transit system and spoke about the opportunities to address the then-looming fiscal cliff (since printing, legislation has been passed). Following breakfast, attendees boarded a private chartered 'L' train to ride through the city's various neighborhoods while listening to remarks by local transit leaders about community projects.



# **Brand Refresh**

In 2024, MPC refreshed its brand and continued building on the pillars established in the strategic refresh of 2023. The refresh embedded elements of geography and maps, introduced an updated color palette (that builds from the previous MPC orange and pulls from the built environment), and established a new tagline that boils down what we do: build equity in the built environment.

Purposeful innovation starts with connection. This year, MPC expanded and deepened the partnerships that united ideas, resources, and determination. Only together, can we transform complex challenges into collective progress.

# Our Great Rivers (Cohort Support)

#### Celebrating seven years of riverfront impact

Since 2016, MPC has played a vital role in advancing the Our Great Rivers vision. Starting in 2017, MPC supported 45 grantees of The Chicago Community Trust (the Trust) across five cohorts composed of diverse civic and community partners working in neighborhoods along the Chicago, Calumet, and Des Plaines rivers. These projects have fostered new collaborations, secured and leveraged additional funding, activated riverfront sites, and made a lasting impact on Chicago's riverfronts through planning and physical improvements. In 2024, MPC concluded its cohort support with a convening that celebrated seven years of transformative work. MPC also updated the Our Great Rivers StoryMap showing the locations and project descriptions of all Our Great Rivers grant funded projects. Collectively, these projects are shaping more equitable and accessible riverfronts for all Chicagoans by reconnecting communities and their rivers.

More than 40% of the Our Great Rivers projects led to physical improvements along Chicago's rivers.

McKinley Park Development Council used their grant to develop a plan for a connected riverfront path from Ping Tom Park to the Daley Boat Launch. This plan is now being rolled into an overall South Branch Framework planning initiative led by the Department of Planning and Development.





# Rivers Ecology & Governance Task Force

#### Partnering for a sustainable riverfront future

MPC has been a cornerstone in supporting the Our Great Rivers vision since its release in 2016. By co-convening the River Ecology and Governance Task Force with the City of Chicago and Friends of the Chicago River, MPC plays a key role in transforming Chicago's waterway system into a thriving, ecologically integrated asset. In 2024, MPC continued co-facilitating collaboration among civic, community, and government partners. The Task Force provided guidance for the Chicago Department of Transportation's River Edge Access Study, with a planning tool officially launched in late summer. The tool includes a StoryMap to share more about the project and the tool's creation and offers valuable resources for planning projects, supporting the ongoing effort to restore and rejuvenate Chicago's rivers for future generations. Additionally, the Task Force kicked-off a new working group focused on creating a more clearly defined governance structure for riverfront assets and reviewed and provided input on new developments along the Chicago river.

As part of our advocacy work and commitment to our partners, MPC leads or supports testimony to the issues that matter.



# Sustainable Development Policy

Championing a more inclusive, resilient sustainable development policy

In April 2024, MPC submitted testimony in support of the City's update to the Chicago Sustainable Development Policy, a framework that encourages sustainable design in projects receiving public funding or special approvals. In a letter to the Chicago Plan Commission, MPC commended the City for expanding engagement beyond traditional stakeholders to include advocates from environmental, housing, public health, and community development sectors. MPC's input, rooted in its work co-convening the River Ecology and Governance Task Force, emphasized the importance of improving river health, expanding access to affordable housing, and advancing public health outcomes. Across all its work, MPC continues to advocate for development standards that promote equity, innovation, and climate resilience across all Chicago neighborhoods.



MPC facilitated 15 Task Force related meetings, with an average participation of 40 stakeholders at quarterly meetings.

Based on input from the Task Force, four new river-focused strategies were developed and included in the 2024 revision to the City's Sustainable Development Policy.

Our Great Rivers project teams from the last seven years celebrated their work at MPC's office in May 2024. Attendees drew their favorite river activities, put together as a mural.









# **Reconnecting Communities**

#### Reimagining infrastructure through community vision

Building on the momentum of our 2023 *Reconnecting Communities* report, MPC continued to advance community-led solutions that repair the historic harm of transportation infrastructure. In 2024, we deepened our collaboration with the Coalition for a Better Chinese American Community (CBCAC) and Design Trust Chicago (DTC), co-developing a community engagement plan focused on the viaducts in Chinatown along S. Canal St. Together, we released *A New Vision for the Canal Street Viaducts* and worked with the Chicago Department of Transportation (CDOT) and Alderwoman Nicole Lee to identify implementation pathways for quick-build projects. With direct input from residents, the project turned community priorities into rendered design concepts—bridging the gap between ideas and action. In parallel, MPC explored how to eliminate policy barriers to tactical urbanism by researching regulatory and funding models from peer cities.

MPC participated in six planning meetings with CBCAC and DTC to develop the project's community engagement plan and design process.


# Homeownership Lending Partnership

#### Shaping a more inclusive path to homeownership

Homeownership is one of the most important vehicles for building household wealth, creating a pathway for families to increase their economic security and pass down generational wealth. In partnership with The Chicago Community Trust (the Trust), MPC continued to advance efforts to address the homeownership gap through actionable solutions. Throughout 2024, MPC facilitated regular workshops that strengthened collaboration between community development financial institutions (CDFIs) and housing counseling agencies. These workshops provided project teams with opportunities to co-create the tools, knowledge, and networks necessary to develop innovative housing finance products with the goal of increasing access to homeownership and purchasing power for low- and moderate-income (LMI) residents of color.

MPC facilitated six workshops for the Community of Practice (CoP) of lenders and housing counselors, where MPC developed post-workshop summaries tracking participant progress on lending product development and implementation challenges.

Three project teams received renewed grants from the Trust.





# Cooperation in Calumet Region Planning

# Design Guidelines & Land Use Update, Conservation Action Plan

#### Advancing equitable land use and environmental stewardship in the Calumet region

MPC continued its long-standing work in the Calumet region by working with several partners, including the Alliance for the Great Lakes, UIC's Great Cities Institute, Southeast Environmental Task Force, Calumet Collaborative, and Friends of the Chicago River to help support the Department of Planning and Development's 2024 launch of the Calumet Area Land Use and Design Guidelines Update through efforts to ensure that Calumet region residents had the information needed to fully participate in the planning process. The goal of the planning process is to establish a vision for the region that balances economic development, public health, and safety, as well as environmental sustainability priorities. MPC is serving as one of the working group members. Also in 2024, MPC developed site-specific feasibility framework action plans for two privately-owned industrial parcels in collaboration with Cleveland-Cliffs and Land and Lakes. These were developed in partnership with the landowners to provide more detailed recommendations to help implement the broad restoration strategies defined in the 2022 Little Calumet Conservation Action Plan.



MPC held conversations with seven critical stakeholders in 2024 to develop a Feasibility Action Plan for Cleveland-Cliffs and Land and Lakes.





# Department of Housing (DOH) Change Teams

#### Embedding equity through public sector partnership


MPC's Change Teams served as a catalyst for systems change within city government by supporting public sector leaders in embedding equity into day-to-day operations through hands-on workshops, coaching, and project implementation support. In 2024, MPC deepened its partnership with the Department of Housing (DOH) to advance specific equity-based projects through facilitated workshops that focused on work planning, problem-solving, and collaboration. The Home Repair team improved their intake processes, including partnering with 311 to expand intake timelines, revising income requirements, and broadening eligibility criteria to make services more accessible. The Construction and Compliance team worked on improving equitable access for women and minority owned businesses to engage with the city's development processes. This included a new informational webinar series, opportunities to take relevant free classes through Chicago Community Colleges, and a new initiative to apply for back-end administrative support to grow businesses. Concurrently, DOH's Bureau of Community Engagement, Racial Equity, and Strategic Initiatives (CERESI) Team continued to develop practical strategies rooted in equity principles and informed by community experience. MPC helped teams refine their approaches and navigate challenges—laying the groundwork for lasting culture, process, and policy change across city departments.

MPC conducted over 6 workshops with the staff at the Department of Housing.

MPC deepened its partnership with the Department of Housing (DOH), advancing implementation of the Home Repair Team's equity project.

# Equitable Transportation-Oriented Development (ETOD) Systems Change Working Group + Scorecard

#### Sustaining momentum for ETOD

Building on the momentum of the Connected Communities Ordinance, MPC continued its work to ensure equitable implementation of transit-oriented development (ETOD) that advances racial equity and benefits all communities. In 2024, MPC circulated a scorecard to evaluate ETOD proposals through an equity lens, convening Elevated Chicago's project team, policy working group, and community partners to refine the tool and ensure it reflects neighborhood priorities. At the same time, MPC continued its co-leadership of Elevated Chicago's Systems Change Working Group, the city's only standing group focused exclusively on long-term ETOD policy. Through this work, MPC and its partners sharpened strategies to strengthen affordability, prevent displacement, and support housing stability near transit. Together, these efforts build the foundation for a more equitable, connected Chicago, where development works for everyone.



# State of Water

#### Equipping leaders for a resilient water future

Across Illinois, elected officials play a vital role in ensuring communities have access to clean, safe, and affordable drinking water. Through our Drinking Water 1-2-3 Academy and technical assistance offerings, MPC has helped bridge this gap, providing local leaders with the education and tools to prioritize sustainable, equitable water decisions. During Chicago Water Week in May 2024, MPC successfully convened more than 70 water sector leaders from across the region for an energizing day titled *A Vision for Water: Planning for Abundance and Scarcity in Illinois*, facilitating field-based learning across the Calumet region. After ten years of administering and promoting the Calumet Stormwater Collaborative (CSC), MPC acted early in 2024 on an opportunity to partner with Friends of the Chicago River through the Greater Chicago Watershed Alliance (GCWA) to establish a long-term administrative home for the CSC. This opportunity, which grew out of MPC's engagement with the GCWA, was realized at a critical juncture when MPC was assessing the impact of the CSC.

MPC partnered to host four field tripstyle convenings to visit projects across the Calumet region.



The field trips brought practitioners out at various planning, design and implementation stages. They were designed to provide hands-on experience with stormwater projects applied at different regional scales, building on the goal of researching the best practices at various scales.

# Lead Service Line Replacement

## Building community capacity for lead-free water

Every community in Illinois deserves access to clean, safe drinking water, regardless of zip code or income. While replacing Illinois's toxic lead service lines remains one of our time's most urgent infrastructure challenges, it is also one of the greatest opportunities to invest in public health, equity, and jobs. While a 2021 state law requires all lead service lines to be replaced, many communities still lack the resources, staffing, or support they need to protect their residents, especially for Black and Latinx communities disproportionately affected by lead exposure. Throughout the year, MPC co-hosted five community workshops across Chicago, Cook County, Rockford, and Peoria to hear directly from residents about how Lead Service Line Replacement (LSLR) should be funded. We also convened four workforce strategy sessions with advocates and training organizations to prepare for the scale of work ahead. To better understand what local governments need, MPC interviewed mayors and utility leaders from four municipalities and developed a memo for the Environmental Defense Fund, helping shape a national Mayor's Roadmap.





# Sustainable Transit Campaign

#### Championing sustainable funding and governance for transit's future

As the region edges closer to the impending transit fiscal cliff in 2026, MPC has intensified efforts to ensure a stable and equitable future for public transportation. In 2024, MPC played a leading role in shaping the Metropolitan Mobility Authority Act, a bold legislative proposal to modernize transit governance and secure long-term funding. Through policy briefings, blogs, and educational engagement with legislators, we worked to build momentum for sustainable solutions that reflect transit's critical role in advancing equity, climate action, and economic growth. In September, we hosted *Imagine Sustainable Transit*, featuring a privately chartered 'L' tour and reception spotlighting the value of a connected, well-funded system. By demonstrating how governance reform and long-term investment can deliver better outcomes for riders and communities, MPC continues to push for bold, collaborative solutions to preserve and strengthen our transit future. MPC remains a trusted convener and advocate, helping to shape a resilient transit system that meets the moment and moves our region forward.

As of printing, the Northern Illinois Transit Authority Act passed the Illinois General Assembly! This is a major milestone in Illinois and MPC will continue to be involved in coalition to shape the implementation strategies and plans.

# Riding the Rails in Germany

MPC joined 10 legislators and five labor leaders in December 2024 on a trip to Germany to experience regionally integrated transit systems in Berlin and Munich and discuss how this could inform legislation efforts in Illinois.

# Architectural Technical Standards Manual (ATSM) Updates

#### Modernizing affordable housing design standards

In partnership with the Chicago Department of Housing, MPC supported an update to the City's Architectural Technical Standards Manual (ATSM), which governs design, construction, and contracting for all City-funded multifamily affordable housing developments. Last updated in 2023, the goal of the ATSM is to ensure high-quality housing design, protect resident well-being, and support equitable and competitive construction practices. As part of the Cut the Tape initiative, this update addresses long-standing feedback from developers, architects, and contractors to streamline processes while maintaining strong standards. In 2024, MPC conducted research, including interviewing agency staff in peer municipalities and reviewing related guides and documents, and co-facilitated monthly Steering Committee meetings. Both the first and second draft of the updated manual are now available, which reflects broad input, prioritizes equity, and supports the production of high-quality, affordable housing across Chicago.

As of printing, the ATSM updates were incorporated into the most recent drafts.

Six Steering Committee meetings were hosted in 2024 across a range of topics from investigating change orders to three-bid requirements to individual design standards that are part of the ATSM.

The Steering Committee includes 16 regular members as well as rotating staff from DOH and the Mayor's Office.





# Right Infrastructure, Right Place

#### Building sustainability through green infrastructure investment for the greatest strategic impact

As climate change accelerates, vulnerable communities in Chicago and the region continue to bear the brunt of urban flooding and heat stress. In 2024, MPC launched Right Infrastructure, Right Place (RIRP), a community-scale, data-driven prioritization tool designed to guide equitable, climate-resilient green stormwater infrastructure (GSI) investments across Chicago and Cook County. Informed by a national scan of emerging practices, including advances in climate modeling, data analytics, and triple bottom line valuation methods, and by newly available data from local stormwater agencies, this methodology is being developed to help decision-makers direct stormwater investments where the need and potential for impact are greatest. This lays the groundwork for a more just approach to GSI investment. The initiative extends MPC's StormStore™ partnership with The Nature Conservancy, whose regional stormwater credit market was renewed by the Metropolitan Water Reclamation District through 2025. Together, RIRP and StormStore™ position MPC to channel future GSI investments toward the communities most vulnerable to flooding and heat—building a smarter, more resilient Chicago.

RIRP is now piloting with Blacks in Green and Emerald South Collaborative in the City of Chicago, and the City of Calumet City in south suburban Cook County. Case studies from our Chicago-based partners are being applied at multiple spatial scales to validate and refine RIRP's assumptions before broader rollout. These case studies also build a stronger investment case for GSI within the plans, aligned with actual capacity limitations in local sewers. The City of Chicago's Green Stormwater Infrastructure Strategy and Plan update, scheduled for release by the end of 2025, will include case studies.


MPC is positioned to help turn data into equityfocused, climate-resilient solutions for high-need blocks. Two neighborhood case studies—Sustainable Square Mile (Blacks in Green) and Terra Firma (Emerald South)—will be folded into Chicago's updated GSI Strategy.



# **Zoning & Land Use Assessment**

#### Zoning for equity and opportunity

Zoning supports how land is used and developed. It shapes the way people live, work, and move through their neighborhoods. MPC continued advancing its Citywide Zoning and Land Use Assessment in partnership with the Urban Institute and a dedicated Steering Committee and Community Advisory Group. Through collaborative research and stakeholder engagement, MPC examined how zoning influences three neighborhood outcomes—limited pollution exposure, affordable housing, and strong business corridors. Over the year, MPC convened stakeholders to review research and outline a zoning and land use toolkit, hosted an event featuring a panel of national experts with more than 200 attendees, and deepened engagement with City Council members to understand how they approach zoning and development in their wards. By evaluating the historic and current impacts of zoning on health, equity, and sustainability, creating recommendations, and implementing reforms, this project supports creating more livable and vibrant Chicago.



MPC staff presented initial research findings to the Chicago Metropolitan Agency for Planning (CMAP) and hosted a virtual gathering of Alderperson staff from approximately 10 ward offices.



# Cut the Tape

# Advancing development reform for a more equitable Chicago


MPC has worked across multiple projects to identify barriers within Chicago's development system, particularly those impacting equity and efficiency. Our findings from supporting We Rise Together grantees, small developers and small business owners on the South and West sides, combined with data and reflections from interviews with practitioners, architects, business owners, and developers collected as part of our Citywide Zoning and Land Use Assessment, positioned us to contribute meaningfully to the Mayor's Cut the Tape initiative. Throughout 2024, MPC played a key role in launching Cut the Tape by providing data analysis on permitting and cases before the City's Zoning Board of Appeals as well as participating in roundtables to understand Chicago's challenges and potential solutions. MPC is a co-chair of the Cut the Tape Task Force, helping to structure and host meetings, facilitate discussions of the 50-member Task Force, and define metrics to track the success of the initiative. Together with partners across the public and private sectors, we are helping to build a development process that is faster, fairer, and better positioned to meet the city's urgent affordable housing and small business development needs.

The City has been chipping away at the 100+ recommendations in the *Cut the Tape* report, with around 90% of them being in progress as of 2025.



Advancing equitable development through new public investment tools


Passed in April 2024, the Housing and Economic Development Bond marked a shift in how Chicago funds housing and community development, moving beyond Tax Increment Financing to generate new, flexible resources for equitable investment. MPC's earlier Equitable Financial Incentives project argued for the need to center equity in the allocation of funds. In 2024, MPC testified in subject matter hearings and at the Chicago City Council Committee on Finance in support of the bond, uplifting its potential to prioritize disinvested communities and improve transparency. Already, bond proceeds are being put to work. In North Lawndale, they're supporting the Missing Middle Housing Initiative to revitalize vacant City-owned lots and expand homeownership. In West Englewood, they're helping grow the Wood Street Farm, an urban agriculture and workforce development hub. The bond also set aside \$135 million to launch Green Social Housing, a public-private model to deliver permanently affordable, environmentally sustainable homes. The Green Social Housing ordinance to establish a nonprofit entity to administer this program was approved by City Council in 2025.




# Financial Summary
